



SPRINTCAR ASSOCIATION OF W.A. (INC)

POLICY

COMMITTEE:

- 1.1 That the SAWA (Inc) Management Committee to consist of minimum of five (5) Committee persons plus President, Vice President, Secretary/treasurer & Technical Director
For preference these five (5) persons to be:
Two (2) Open division representatives
Two (2) 360 division representatives
One(1) Independent representatives 7/2011
- 1.2 The Sprintcar Assoc of WA (Inc) to be in control of the SAWA (Inc) Racing/race formats and prize money breakdowns, after consultation with the Sprintcar Entrants Group. The Sprintcar Entrants Group, or any like organization to be a Marketing Group only relative to attaining Contingency Sponsorship and to have NO involvement in the running of sprint car race meetings 5/2001
- 1.3 That the Negotiating Committee be made up of:
Three (3) Persons from Management Committee - and a minimum of any two must attend all/any meetings with Promoters 5/1996
- 1.4 SAWA (Inc) Technical Committee to be made up of the Technical Director plus four (4) other persons & to be decided by Management Committee 5/2002
- 1.5 That any Third Party that wishes to make any changes or to have input that relates to SAWA or its Members, must seek in writing an Approval from the SAWA Inc before any consideration be given. 7/2011

FINANCIAL:

- 2.1 No prize money be paid out to Competitors of SAWA (Inc) Club run events unless full financial members of SCCA. 5/1993
- 2.1(a) The intent is that the minimum prize money for a SAWA (Inc) club run event (standard night) is to be \$10,000 and for a major event a minimum of \$12,000 6/2003
- 2.2 One (1) Rule Book be given free of cost to each Car Owner, Driver, Management Committee Member, Stewards and one to each Affiliated Club. All other rule books at a cost of \$20 ea (or an amount set down by the SCCA) 8/2008
- 2.3 Officials Travel Costs - Minimum of four (4) Stewards, Handicapper, two (2) Machine Examiners, Lap Recorder, Race Secretary, must be paid to attend race meetings outside Metropolitan Area. Amount to be agreed by Management Committee, based on kilometers travelled 09/2010
- 2.4 That Club Affiliation fees be \$250pa 9/2010
- 2.5 All prize money payouts - open and 360 division, to be based on the requirements of their sections but with
1st place prize money payouts whilst racing as separate divisions to be a minimum of
Open division \$2000 360 div \$1000 5/2000

- 2.6 That SAWA/SEG Negotiate for prize monies at the Motorplex-Kwinana on a yearly basis 9/2010
- 2.7 That all Fees be set by the incoming Management Committee
 Car Registration
 Driver's fees
 Car Owner's fees
 Financial/Voting Members' fees
 Social/Non-voting Members' fees
 Nomination fee per car per race meeting
 Nomination fee-State Titles per car per race meeting 5/1999
- 2.8 Race Management fees - will be implemented/used to pay for the Clubs officials travel/equipment hire costs (Nomination fees) 9/2010
- 2.9 Membership - pit crew
 ALL Pit crew must be financial "associate" (non voting members of the SAWA (Inc) 11/2009

MEETINGS:

- 3.1 That all Ballot Papers be destroyed after an Election of Office Bearers. 5/1994
- 3.2 National Delegates - any two (2) preferably from Management Committee must attend SCCA National Conference 5/1997
- 3.3 Voting on all Disputes and Appeals are to be done by Secret Ballot and Disputes Tribunal to set penalties. 5/1995
- 3.4 That the nominations for the following positions to be decided on by Management Committee Disputes/Appeals Committee members (minimum of three) Social Secretary & Social Committee Members 5/2001
- 3.5 That one (1) vote only per registered car, relative to specifications, race formats, prize money etc 5/2001

TROPHIES:

- 4.1 Best Performance Perpetual Trophy and Club Champions - Six highest point scorers from all SAWA (Inc) Club run events - both divisions - from time trials, heats&feature races only 5/2002
- 4.2 Club points for Trophies - from heats and feature races AND must take chequered flag 5/2000
- 4.3 Club Championship points from every SAWA (Inc) Club run event race meeting more than 60kls from the Perth GPO ARE TO BE DOUBLE POINTS 5/2002
- 4.4 That a/any Competitor, suspended for a/any offence cannot partake in the SAWA (Inc) Fairest & Best Awards (positions 1-6) in either "open" or "360" division in that year in which suspended.. If suspension is suspended against a Good Behaviour Bond and Competitor does NOT offend within this Good Behaviour Bond period allocated, then that Competitor can partake in the SAWA (Inc) Fairest & Best Awards (positions 1-6) in either "open" or "360" division in that year. 9/2009

HANDICAPPING:

- 5.1 Handicap System/race formats & Prize money breakdowns to be decided by Management Committee 9/2010
- 5.2 Cars attending Australian Title will be given average Seasons Points for two (2) nights and only if SAWA (Inc) run two (2) meetings during that period. 8/1990

SPECIFICATIONS:

- 6.1 SAWA (Inc) State Tyre rule:
That a Tyre rule to be enforced as seen fit by the SAWA (Inc) Management Committee & SEG 2003
- 6.2 The Penalty for the Owner and Driver of a car caught competing in a SAWA (Inc) Club run event race meeting with illegal tyres to be:
1st offence: Disqualification for night PLUS \$500 Fine PLUS four (4) SAWA Club run event race meeting suspension
2nd offence: Disqualification for night PLUS \$1000 Fine PLUS twelve (12) SAWA club run event race meeting suspension 5/1997

STEWARDS:

- 7.1 That the Chief Steward to submit a Report to Management Committee as per ASRR requirement 9/2010

COUNTRY TRACKS:

- 8.1 Any track being attended by SAWA (Inc) are to confirm in writing two (2) weeks prior to race meeting :-
a) prize money
b) tow money - if applicable
c) officials fees - if applicable
d) race formats
e) confirmation of insurance cover
f) Car count guarantee 5/2000
- 8.2 That Members are allowed to race at other venues in W.A to promote sprintcars PROVIDED they have SAWA (Inc) Management Committee Approval first and that the Track concerned must have proper Liability Insurance in place.
NO permission will be granted to a/any cars to attend a race meeting that SAWA (Inc) have cancelled 9/2010

PROMOTION:

- 9.1 That the Management Committee be empowered to contact and put in charge, a person or persons, to handle the promotion and marketing of Sprintcar Racing in Western Australia 9/1995

STATE TITLES:

- 10.1 SAWA (Inc) State Titles - Open and 360 division - the SAWA (Inc) call for submissions from eligible tracks for State Titles 5/1994

CAR NUMBERS:

- 11.1 Twelve (12) months after ceasing active racing, all racing numbers become Club Property. Car Numbers back on "the market" 18 months after ceasing active racing.
Any person wishing to retain a number for a further twelve (12) months while not in active racing, must apply to the Management Committee in writing for a ruling 9/2010

CRITERIA:

- 12.1 **PRESIDENT:**
1) Must have an understanding of the Constitution, Rules and Regulations and Appeal Procedure of the SAWA (Inc)
2) Must be approachable by Membership
3) Must be able to attend all Race & Committee Meetings 9/2010
- 12.2 **SECRETARY/TREASURER**
1) Must have an understanding of the Constitution, Rules and Regulations and Appeal Procedure of the SAWA (Inc)
2) Must have Computer & Bookkeeping skills incl word/access/excel/publisher/MYOB
3) Must be able to attend all Committee, General and most race meetings
4) Must be available on race nights from 3.30pm onwards 9/2010

- 12.3 **COMMITTEE:**
- 1) Must be a Club Member
 - 2) Must not be a Promoter
 - 3) Must attend all Committee Meetings
- 5/1995

- 12.4 **SOCIAL SECRETARY:**
- 1) Must have good organizing ability and some bookkeeping skills
 - 2) Must be able to type and have own transport
- 9/2010

- 12.5 **DISPUTES COMMITTEE:**
- 1) Must be impartial
 - 2) Must have a minimum of four (4) persons on the Committee
 - 3) With a minimum of three (3) to attend all Tribunal hearings
